Also a quote had been received to change the back entrance door to a proper fire door, and in last months meeting she was advised to go ahead when the quote was received, she asked council if they would accept the proposal, which was voted for with all in favour. 8. Financial Matters

A discussion on Council Tea Room took place, and the RFO was asked to complete an exercise in Income and Expenditure to bring to the Councillors present, there was a consensus that in early 2023 a stock-take should be undertaken.
