# Skellingthorpe Parish Council Meeting Minutes of Meeting held in Community Centre Skellingthorpe Tuesday 27<sup>th</sup> June 2023 at 7pm

Parishioners Questions Time: 3 requests received.

a) Matt Scarborough (resident) spoke on the proposed new Skatepark Plan giving information on 600 signatures on a petition, 100 plus people attending recent consultation meeting along with floods of emails, mainly in support of the project. He gave examples of some of these especial one from a resident who had grownup in the village where there had been at that time no structured activities for teens and explained about the up and coming sport to which he felt a benefit to the village.

Matt asked for the support of the Council on this proposal.

- b) Bob Smart (resident) asked for the Council to consider a Motor Home Rally to be held on the Community Car Park along with booking the Community facilities. He gave a brief outline of the Rally and was advised that Council would be writing to him.
- c) James Howden on behalf of P Robinson (resident) asking if there could be permission for a Bench to be placed in the Cemetery to memory of Noel Robinson deceased. He was advised that Council would also write to him shortly on their decision.

Chair then reconvened the meeting, and advised that the public should not interrupt the meeting unless they were asked to speak by the Chair.

# 1. Apologies for Absence

The meeting was advised that apologies had been received from Cllr L Fear. It was resolved that his apology was a valid reasons and had been accepted.

- Clerks Report. Clerk advised on the problems currently in the Cemetery with the Contractors and grass cutting etc. Problems now rectified. Also a Contractor had been asked to trim the Sweet Chestnut trees adjacent to Woodbank road as these

are overhanging the Garden of Rest and hinder motorists view leaving the Car park. This has been arranged to be done next month.

### 8. Report from Outside Bodies

a) North Kesteven Councillors: Cllr R Johnston advised on the upgraded equipment at the rendering plant installed in the near future. He also advised of the recent Change in Councillors following the NKDC elections.

Cllr C Goldson advised of grass cutting problems in Skellingthorpe. Also parking problems at The Hill where residents are not able to park their vehicles. It could be that Disabled Bays may be placed on The Hill. He gave a huge Thank You for those involved in the recent Kings Coronation event and the 50/61 memorial afternoon, which had both been a great success.

**b)** County Councillor Report: Cllr A Briggs also gave thanks and congratulations on the 50/61 memorial event. He advised that after getting a large amount of complaints regarding parking around St Lawrence School, where he and Cllr Coyle-Fox visited the site. He spoke on correspondence from Skellingthorpe Residents Association regarding pedestrian crossings.

#### 9. Report from Internal Committees

**HR:** Looked at Policies which would be ongoing and bring back to next HR meeting To have monthly Staff Meetings with 3 staff members. Staff Appraisals had been started. Looking at Email system of .gov.uk to be on next HR Meeting in September. **Events:** Gala next year to be 23<sup>rd</sup> June 2024. Looking at an event with Party Workshop on August Bank Holiday Monday 2023.

**Planning Committee:** Advised on the start of 28 new houses on Jerusalem Road and surveys on Birchwood Avenue new road.

**StreetLighting:** Most of the street lights in Skellingthorpe are the responsibility of the County Council (LCC) The Parish Council have up to 50 lights, mainly on private or unadopted roads. Over the last two years these have been repaired where necessary and the sodium lights replace with LED ones. This has now been completed. The 3 lights in the field alongside the Church yard are being repaired 28<sup>th</sup> 29<sup>th</sup> June, Cllr Richardson will be ensuring these are working.

# 10. S106 monies Progress and Information from Architect

A report back was given from the meeting of the 26<sup>th</sup> June 2023 with Architect and committee.

Discussions took place on the plans for a proposed new Pavilion taking them to preplanning application, Grants and consultations with various bodies. A further consultation will take place in the Community Centre for the residents in the near future.

11. Inclusion of Skate Park with movement/replacement of play equipment on S106 project. After hearing from Matt Scarborough and attending the Consultation Cllr G Bright proposed to include the Skate Park project within Pavilion project. Cllr Walshaw although in favour of the Skate Park wished that before the PC takes any main decisions they need to know what the full costs will be, who will run and manage plus

any Insurances required will be in place. He was in favour to support the project, but these details need to be in situ. Cllr Bright then proposed to move the project forward to pre-plan stage with Council All in Favour.

Cllr Bright asked chairs permission to look at prices and bring back to July Meeting All Agreed
  14.Solar Sids Cllr Bright had looked into the SIDs in the village and also three firms providing Solar Sids he gave some information. Current SIDs are coming to end of their life. He asked permission to look further into the matter to bring to July meeting
